DATA COLLECTION NOTES

The population census shall be conducted within 5 days, from January 8 o'clock (by local hour) of January 5 to January 9, 1989. The assigned enumerators shall visit each household (in apartments, dormitories and gers) and fill out the census questionnaire by asking each family. Enumerator shall not conduct census at factories, economic entities, organizations and schools.

The Dataset in this documentation is not a dataset created at the time of the census since the full database of the census is not available anymore. Therefore, the NSO re-entried data of 42783 households and 190631 persons (10 percent of all of population in 1989) from the completed questionnaires that had archived in the National Center Archives in 2007.
